


- Information in or about content provided by users such as location of a photo or the date a file was created.

- Information about how users use Facebook's services type of content viewed or engaged with or the frequency or duration of activities- is also collected.
- Information about how people and groups connect and interact with each other

- Device information, e.g. attributes such as operating system, hardware version, device settings, file and software names and types, battery, signal strentgh and device identifier. Connection information such as name of mobile operator, ISP, browser type, language, time zone

- Payment information such as creadit/ debit card number and other card information, account and authentication information, billing, shipping and contact details
