Software Freedom law Centre (SFLC) is a Non Profit Organization that provides legal representation and other law -related services to protect the digital civil liberties of citizens. Hence we have an interest in ensuring that any restrictions on the digital freedom and the privacy of citizens are introduced only after a due process of law. - Has the approval of the Cabinet Committee on Security been granted? If yes, Kindly provide a copy of the same.
- 3. What is the designation of the Officer Incharge of the NATGRID Project and who does the said Officer Incharge report to?
- 4. What is the budgetary allocations for the NATGRID project.
- What government and private databases will be linked to the NATGRID. If so under what order or rules. Please provide a copy of the same.
- What are the measures in place to prevent the misuse of NATGRID? If yes, please provide a photocopy of these guidelines/circulars.

- 7. What are the various Governmental agencies that will have an access to NATGRID?
- 8. Does this project have any policy favouring Free and Open Source Software(FOSS)?

If yes, have any guidelines/circulars been issued in this regard? If yes, please provide a photocopy of these guidelines/circulars.

If the information sought for is held by another public authority I request you to transfer the application to such authority within a period of five days as per S.6(3) of the Right to information Act, 2005 and to inform me of the same.

I am a 'Citizen' of India and I am asking the information as 'Citizen'.
